Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (3) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (4) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (5) The occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (6) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (7) Licensee must maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees.
- (8) Licensee shall consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the proposed areas.
- (9) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
- (10) The maximum number of trial participants allowed under this market trial is 20.
- (11) This license will not be renewed.
