- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) Operations on 6.7458 MHz, 17.9831 MHz, 156.87 MHz and 168.87 MHz are denied due to potential interference to existing users.
- (3) Licensee shall comply with blanking requirements on the following frequencies.
 1. Blank transmissions +/- 2 MHz from 1211 MHz.
 2. Blank transmissions +/- 10 MHz from 1227.6 MHz.
 3. Blank transmissions +/- 12 MHz from 1575.45 MHz.

- (8) No operation is allowed to use the following frequencies: 92.146 MHz, 96.753 MHz, 101.591 MHz, 106.67 MHz, 1231.35 MHz, 1425.25 MHz, and the band 234.54 - 383.15 MHz.
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the Department of Army contract number DAAB0703DB006/0056. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (10) The stop buzzer, Jole Cline, phone 405-219-3400 or 405-200-9665 must be available during the test to terminate transmissions if interference occurs.
