This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Special Conditions:

- (1) ARRIS must maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees.
- (2) ARRIS shall consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the proposed areas.
- (3) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
