- (3) Licensee must obtain consents from the Broadband Radio Service licensees prior to accessing to the frequency range from 2496 MHz to 2500 MHz.
- (4) Experimental licensee must coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation in the frequency range from 2450 MHz to 2500 MHz.
- (5) Experimental licensee must coordinate with Fixed Microwave Service licensees in the corresponding proposed venue in accordance with 47 C.F.R, Part 101.103(d) prior to accessing to the frequency band from 2450 MHz to 2500 MHz.
- (6) Prior to commencing any operations in the 2483.5 - 2500 MHz frequency band, experimental licensee must notify licensee of GUSA Licensee LLC. (Call sign E970381, S2115. Name: Mr. L. Barbee Ponder IV Phone Number: 985-335-1503 E-Mail: Barbee.Ponder@Globalstar.com). The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should include the testing parameters (specific location(s), antenna gain(s), antenna height(s), antenna orientation, EIRP, EIRP density) and day and times of each test.
