This letter serves to explain, in relevant part, the restructure of AT&T Corp. ("AT&T") and the resulting need to assign certain radio licenses now held by AT&T to a new corporation.

AT&T intends to establish in a new, separate corporation its present communications systems and technology business, including the associated R&D functions. Those activities are presently conducted by business units and divisions within AT&T, which holds the radio station licenses used in connection therewith. The steps in this restructuring are:

1. A new wholly owned AT&T subsidiary to conduct those activities has been established. The present name of that subsidiary is NS-MPG Inc.

2. The resources needed by NS-MPG Inc. to conduct its business will be transferred to it and it is expected to be operational early in 1996.

3. Thereafter, AT&T may offer approximately 15% of the stock of NS-MPG Inc. to the public.

4. In any event, on or before January 1, 1997, AT&T will distribute the balance of the stock of NS-MPG Inc. to the existing AT&T shareholders.

Commission consent to the transfer of the radio station licenses identified in this application will assist the new corporation to operate efficiently and thus is consistent with the public interest.
