Special Conditions:

- (1) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (2) Licensee must avoid pointing the transmitting antenna main beam gain within 10 degrees of any point on the geostationary orbital arc while transmitting signals in the 27.5-28.5 GHz band.
- (3) Licensee shall ensure that the transmitting fixed station antenna(s) main beam gain tip down when possible and avoid pointing above the horizon to protect satellite stations.
