- (4) Licensee shall maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (5) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
