This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

Testing a transmit antennas height of up to 29.25 meters above the ground, with a slightly expanded mobile area of operation of .20 km radius around the specified centerpoint.

Special Conditions:

- (9) Operation is NOT allowed using the frequency band 406.1-420 MHz.
- (10) The frequency 345 MHz is to be NOTCHED OUT to protect Coast Guard operations in the area.
- (11) BAE acknowledge that the 462.95-463.175 MHz frequencies are being used for medical radio communications and shall avoid harmful interference to medical devices.
- (12) Restrictions still apply from previous FCC licenses: 0221-EX-ST-2005, 0060-EX-ST-2006, and 0168-EX-ST-2006.
- (13) This license SUPERSEDES the previous issued license with the same callsign and file number: amends the special condition.
