- (5) Operation must NOTCH OUT +/- 300 kHz of the frequency 422 MHz and +/- 100kHz of the frequency 425 MHz.
- (6) The Federal Aviation Administration (FAA) will not support any non-standard system development in the bands that are contrary to the table of frequency allocations.
- (7) BAE Systems must coordinate with Western Area Frequency Coordinator, Mr. Hernandez, 805-989-7985, Michael.hernandez@navy.mil prior to testing at Ocotillo, CA.
- (8) The designated point-of-contact to terminate transmissions if interference occurs is Brian Egan at (603)718-2305, Brent Forman at (603)809-7308 or Adam Sayer at (603)718-4183.
- (9) Operation is NOT PERMITTED using the following frequency bands: 1790-1849 MHz, 2200-2290 MHz, 2291-2299 MHz, 420.5-421.5 MHz, 425.7-425.8 MHz and 428.7- 428.8 MHz.
- (10) Operation on this assignment is subject to immediate cessation, if it causes harmful interference to US Air Force assignments.
- (11) During transmission, aircraft shall not exceed the altitude listed in the circuit remarks field 0120, AGL.

Special Conditions:

- (12) This license SUPERSEDES the previous issued license with the same callsign and file number: amends Special Condition 11.
