Special Conditions:

- (1) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to authorization with the HQ USAF Frequency Coordinator, Alexandria, VA., who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the HQ USAF Frequency Coordinator, Alexandria, VA., as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.

Special Conditions:

- (5) The band 2345-2360 MHz has been re-allocated on a primary basis to the Wireless Communications Service (WCS). Additional coordination with WCS is required.
- (6) Licensee must get consent from the Advanced Wireless Service, Education Broadband Services and Broadband Radio Service licensees prior to operations.
- (7) Operation is subject to coordinate with the local SBE frequency coordinator and the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d).
- (8) Licensee must maintain separation from the grandfathered earth stations as defined in Part 90 subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz
- (9) Ensure that the operations will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the area.
- (10) Operation is NOT PERMITTED using the frequency band 4990-5000 MHz.
- (11) Operation is subject to prior coordination with FAA Eastern Regional Office, JFK International Airport, NY 11430, Attn: Frequency Management Office; Telephone 718-712-8343.
- (12) The designated point-of-contact to terminate the systems if interference occurs is George Moynihan - (603) 689-8630 and BAE Systems Emergency Services Center - (603) 885-3842.
- (13) For the radiolocation frequencies 2745.275 MHz, 2768.6 MHz, 2851.6 MHz, and 2856.2 MHz, previous coordination requested sector blanking 0-270 degrees true north. If there are any issues with this request, please contact Thomas Ahn 202-493-4909.
- (14) This license SUPERSEDES the previous issued license with the same callsign and file numbers: adding the condition.
