Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) In the band 7125-10000 MHz, licensee shall exclude operations on the following frequencies plus or minus 10 MHz: M7186, M7310, M7410, M7500, M7605, M7700, M7710, M7810, M7925, M8005, M8090, M8170, M8210, M8250, M8290, M8330.
- (4) Operation in the frequency bands 1435-1535 MHz or 2310-2390 MHz is subject to prior coordination with the Aerospace and Flight Test Radio Coordinating Council (AFTRCC).
- (5) The designed point-of-contact to terminate transmissions if interference occurs is Mr. Johnson 603-689-8630.

Special Conditions:

- (6) Operation in the frequency bands 960-1400, 2700-3000, or 9000-9200 MHz is subject to prior coordination with the FAA Regional Coordinators.
- (7) This license SUPERSEDES the previous issued license with the same callsign and file number: amends the special condition.
