- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Operation in the 763-768 or 793-798 MHz band requires consent of the Public Safety Spectrum Trust Corporation (PSST) to avoid interference.
- (4) Operation in the 763-768 or 793-798 MHz band requires consent of 700 MHz waiver recipient(s), in areas where such waivers have been awarded, to avoid interference.
- (5) Operation is subject to prior coordination with the Society of Broadcast Engineers, Inc. (SBE); ATTN: Executive Director; 9102 North Meridian Street, Suite 305; Indianapolis, IN 46260; telephone, (866) 632-4222; FAX, (317) 846-9120; e-mail, executivedir @ sbe.org; information, www.sbe.org.

Special Conditions:

- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Air Force; contract number FA8620-11-G-4029. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) The applicant agrees to accept and implement any future modifications to their operation as directed by the FAA to include ceasing operations, or adding additional frequency restrictions so that future FAA operational requirements can be supported.
- (8) Authorized Power ERP shall not exceed 0.007 Watts.

- (10) Operation is NOT PERMITTED using the frequency band 763-775 MHz and 793-805 MHz.
