Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Due to safety of life issues the bands 74.8-75.4 MHz .
- (5) The following distress, safety and calling frequencies can not be used plus or minus 1.5 kHz: 2183.4 kHz, 3024.4 kHz and 4126.4 kHz.
- (6) Operations on the frequencies 130 MHz and 132 MHz must be prior coordinated with ARINC.
- (7) This license supersedes previous grant.
- (8) The designated point-of-contact to terminate transmissions if interference occurs is Mr. Egan at (603) 885-3173.
- (9) Operation is subject to prior coordination with FAA Eastern JFK International Airport, New York, ATTN: Frequency Management Office, phone (718) 712-8343.
- (10) Operation must NOTCH OUT +/- 25 kHz of 75 MHz.
