Special Conditions:

- (1) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA New England Coordinator, Burlington, MA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA New England Coordinator, Burlington, MA, as necessary to ensure compatibility with existing uses.

Special Conditions:

- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to authorization with the HQ USAF Frequency Coordinator, Alexandria, VA., who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the HQ USAF Frequency Coordinator, Alexandria, VA., as necessary to ensure compatibility with existing uses.
- (5) "Stop Buzzer" contact Rick Ball at (603) 318-6913 or BAE Systems Emergency Services Center at (603) 885-3842 shall be available during testing to cease operations in the event of any interference.
- (6) Licensee must follow Air Force restrictions in order to use the frequency band 2310-2320 MHz or 2345-2390 MHz:
 1. Send an email to hanscom.spectrum@hanscom.af.mil prior to starting each test identifying the test, location, Stop Buzzer and anticipated duration of the test event.
 2. Stop Buzzer contact must be at the test location and available during the entire duration of the test.
- (7) Operation is NOT permitted using the following frequencies band: 174 - 228.6 MHz, 228.8 - 328.6 MHz, 335.4 - 454 MHz, 23.6 - 24.25 GHz and 25.25 - 26 GHz.
- (8) A renewal of this license is subject to prior coordination with Federal Aviation Administration (FAA) and Aerospace Flight Test Radio Coordination Council (AFTRCC).
