- (8) No operation is permitted to transmit in any public safety frequencies listed under Part 90.20 unless coordinated with the licensed public safety entity.
- (9) Operation in the 1710-1755, 1915-1920 MHz and 1995-2000 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
