- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (7) This frequency assignment in one of the bands 1435-1535 or 2310-2390 MHz was coordinated prior to authorization with the Mid-Atlantic Area Frequency Coordinator (AFC), Patuxent River, MD, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. - (13) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the related U.S. Navy contract(s) N00019-09-C-0019 and N00019-10-C-0078. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (14) Operations in the frequency 1435-1525 MHz must not interference with, and accept interference from, aeronautical telemetry operations.
