- (3) The following frequencies are denied due to objections over possible interference. No operations are permitted on: 25.55-25.67 MHz, 73-74.6 MHz, 88-106.4 MHz, 108.5-118.4 MHz, 125.6-128.8125 MHz and 132.0125-135.2 MHz, 176-205 MHz.
