Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Operation is subject to prior coordination with the existing and future Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) for the following frequencies: 6108 MHz, 6200 MHz, and 6560 MHz.
- (4) Operation shall immediately cease if such operation causes harmful radio interference to the other microwave users.
- (5) The designated point of contact to terminate the systems if interference occurs is George Moynihan (603) 689-8630 or BAE Systems Emergency Services Center (603) 885-3842.
- (6) Operation the frequency 1010 MHz shall not exceed 10 watt (ERP).
- (7) Operation is not permitted using the frequency band 3700-4200 MHz and 6400 MHz.
- (8) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by USAF, FA8620-16-G-3028. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
