Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to its authorization with the Area Frequency Coordinator (AFC), Ft. Huachuca, Arizona, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFC, Ft. Huachuca, Arizona, as necessary to ensure compatibility with existing uses.
- (4) Operations must cease if they result in harmful interference to NASA balloon operations in the 2360 - 2400 MHz band.
- (5) Operation is subject to prior coordination with the Installation Spectrum Manager (ISM) at Davis Monthan Air Force Base for any tests conducted in the following frequency range M1755-1850. - (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the US Military contract number: N68335-08-C-0474, W15P7T-09-C-S007 and FA8650-10-C-7037. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is Christopher Troudt at 520-240-2974.
- (8) Operation is subject to prior coordination with Advances Wireless Service licensees in the nearby area prior to operating on the 1755-1850 MHz band.
- (9) Operation is NOT PERMITTED on the frequency band 225-399.9 MHz due to potential interference to Federal Government operations.
- (10) This license SUPERSEDES the previous issued with the same callsign and file number: amend the contract numbers.
