- (3) Prior to operation BAE Systems needs to coordinate use with the Frequency Coordinator at Patuxent River, MD at 301-342-1532.

Special Conditions:

- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Navy Contract No. N00024-03-C-2310.. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Licensee has submitted an interference study and is aware of potential interference to Part 101 and Part 25 licensees in the 3700-4200 MHz and 5925-6425 MHz bands. Licensee is subject to immediate shut down in the event of harmful interference
- (6) Tina Green shall be available during testing at 240-538-8351 to act as a Stop Buzzer point of contact.
