Special Conditions:

- (4) The designated point-of-contact to terminate transmissions if interference occurs is Mr. James Murray at (303) 939-5573.
- (5) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (6) Ball Aerospace and Technologies Corp. shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (7) The test equipment shall only be used indoors and shall be under the control of Ball Aerospace and Technologies Corp..
- (8) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
