("SBC") filed applications to transfer numerous FCC authorizations to a newly-created company, Alloy LLC, which will be jointly controlled by BSC and SBC. *SBC Communications Inc. and BellSouth Corporation Seek FCC Consent to Transfer Control of, or Assign, Licenses to Joint Venture*, DA 00-1120, Public Notice, (rel. May 19, 2000). Related to that transaction, BSC filed an application to transfer control of BSPC Inc. and Station KA2XBT to Alloy LLC. This application remains pending before the Commission. Simultaneously, with the instant filing, BSC is amending its transfer of control application to reflect the licensee name of station KA2XBT as BSPC LLC.
