- (3) Licensee must get consents from the Advanced Wireless Service licensees prior to accessing to 1710-1755MHz and 2110-2155MHz.
- (4) Licensee must coordinate with the affected incumbent Fixed Microwave Service licensees prior to operation in 1930-1990MHz.
- (5) Blue Danube Labs must get consent of ALL PCS licensees within 25 miles of the locations of the test.
