NAME Blue Origin Texas, LLC

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

This application is for one suborbital flight of the launch system which includes a booster and capsule.

Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) All Blue Origin operations granted on an experimental basis shall be on an unprotected, non-interference basis to authorized stations. All spacecraft transmission to the ground shall be pre-coordinated for clearance for operation in accordance with each of the conditions specified below.
- (4) This STA is limited to launch vehicle communications for the telemetry transmissions and reception, no earlier than 1 April 2020, to support a single flight of the New Shepard space launch booster and capsule. This STA will expire as soon as the launch has been completed or 1 June 2020, whichever occurs first. Applications for any future launches, or modifications to this STA, shall be submitted to the FCC for re-coordination with NTIA.
- (5) All transmissions in the band 2200-2290 MHz shall comply with national and international power flux-density limits, except in cases where expected exceedances are pre-coordinated and agreed-upon.
- (6) The Stop Buzzer information, for launch operations shall be provided to NTIA (bmitchell@ntia.doc.gov). This phone shall be manned 24/7.
- (7) As soon as possible, but no later than 60 business days prior to commencing flight operations, Blue Origin shall provide, as a minimum, launch date/window and planned first and second-stage trajectory, transmission frequencies with associated duration/cut-off time to: Jimmy Nguyen (jimmy.nguyen@us.af.mil), NASA GSFC Spectrum Management Office (NASA-DL-GSFC-Spectrum-Management@nasa.gov), Richard Ontiveros (richard.ontiveros1.civ@mail.mil), Stephen Harris (stephen.b.harris6.civ@mail.mil), Carmelo Rivera (carmelo.rivera@noaa.gov), Robert Avery (robert.avery.9@us.af.mil), and Cathy Sham (catherine.c.sham@nasa.gov). In the event of last-minute changes, 48-hour notice is required.
- (8) Blue Origin Texas, LLC must coordinate with the Naval Surface Warfare Center, Dahlgren Division (NSWCDD), group email box; W_DLGR_NSWC_FTMA_FM@navy.mil. Primary frequency coordination contacts; Mr. James Moneyhon, (540)653-3477- james.moneyhon@navy.mil, Mr. A. Jason Verdugo, 540-653-9590 – Anthony.J.Verdugo@navy.mil, and/or Mrs. Lory Santiago, (540)-653-0096 – lory.santiago@navy.mil , a minimum of 60-days prior to the flight test.
- (9) Blue Origin must coordinate their operations, with the DoD-AFC (WSMR) office, at least 96 hours prior to operation, via e-mail to usarmy.wsmr.imcom-central.list.dodafc@mail.mil. Blue Origin will provide dates/times of tests, and an electronic copy of the final FCC License, under which they will be operating.
- (10) Blue Origin Texas, LLC should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (11) Blue Origin Texas, LLC shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.

Special Conditions:

- (12) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
