Special Conditions:

- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Licensee shall comply with the terms and conditions agreed upon and stated in the application file exhibit titled "International Bureau License Conditions"
- (5) Prior to operating in the 14.0-14.2 GHz frequency band, in the listed locations, Boeing will coordinate with National Aeronautics and Space Administration (NASA) and notify the Commission of the results of that coordination:
Within 125 km of the NASA TDRSS facilities in Guam (latitude 13° 36' 55" N, longitude 144° 51' 22" E) or,
Within 125 km of the NASA TDRSS facilities in White Sands, New Mexico (latitude 32° 20' 59" N, longitude 106° 36' 31" W and latitude 32° 32' 40" N, longitude 106°36' 48" W) or,
Within 125 km of the NASA TDRSS facilities in Blossom Point, Maryland (latitude 38° 25' 44" N, longitude 77°05' 20" W).
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by U.S. Air Force Material Command ("AFMC") contract number F33657-01-D-0013. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
