- (5) Operation is limited to activity for the purpose of testing radio-navigation satellite service (RNSS) equipment and systems.
- (6) The Boeing Company shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (7) The test equipment shall only be used indoors and shall be under the control of the Boeing Company.
- (8) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (9) Licensee has submitted calculations that predict that the installation will be at or below the limit specified in NTIA manual section 8.3.28
