Special Conditions:

- (4) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (5) The designated point-of-contacts to terminate transmissions if interference occurs are Mr. Gary Hart at (314) 705-2358, Mr. Glen Seganfredo at (314) 705-2349 and Mr. Ross Dunagan at (314) 306-4632.
- (6) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (7) Licensee is required to post signs on doors to the testing area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (8) No EIRP greater than -140 dBm/24 MHz at 100 feet is used.
- (9) The test equipment shall only be used in doors and shall be under the control of Boeing Company.
