Intend to operate IEEE 802.16e (Mobile WiMAX) equipment in licensed frequency bands.

Purpose of Operation :
Evaluate the RF performance of commercial IEEE 802.16e (Mobile WiMAX) equipment for United States Air Force Global Broadcast Service applications.
