This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

- (5) Operation in the 896-901 or 935-940 MHz band requires consent of local SMR licensee(s) to avoid interference.
- (6) Future applications to renew this authorization will not be considered.
