This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Broad Comm must get consent from the Advance Wireless Service licensees prior to operation on 2170 MHz.
- (4) Broad Comm Inc. must get consent from the Educational Broadband Service licensees prior to accessing 2505 MHz, 2520 MHz and 2535 MHz.
- (5) Operation is subject to coordinate with the local Society Broadband Engineer frequency coordinator prior to utilizing the rest of the proposed frequency bands.
