This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Prior to the games in Anaheim/Los Angeles, CA, Washington, DC, and St. Louis, MO a STOP BUZZER Point of Contact must be furnished to:

- (4) Broad Comm must be made aware that the band 2200-2290 MHz is allocated for federal only use for satellite and fixed line-of-sight operations. Non-federal use is on a case-by-case basis. Broad Comm should have no expectations on automatic approval in this band in future submissions.
- (5) Broad Comm must limit the operations to the interior of the event arenas requested.
- (6) Broad Comm must not utilize the frequency 2210 MHz, 2225 MHz and 2230 MHz to protect ongoing law enforcement operations in the New York, NY area.
- (7) At the Washington, DC location, Broad Comm must not utilize 2210 MHz, 2225 MHz and 2230 MHz to protect ongoing law enforcement operations in the area.
- (8) Emission bandwidth overlap is not authorized and will not be tolerated.

Special Conditions:

- (9) The following frequencies must be notched to protect Department of the Interior operations at the locations indicated:
