- (4) Licensee must get consents from the Educational Broadband Service /Broadband Radio Service licensees prior to accessing 2620 MHz
- (5) Operation is subject to coordinate with the local Society of Broadcast Engineer frequency coordinator prior to operation on 451.3 MHz, 452.3 MHz and 455.5 MHz.
- (6) Broad Comm must notch out the frequency 410.9 MHz within Fort Worth, TX.
