MIDLANTAFC does not object to the lower L band usage (Frequency: (MHz) 1445.0/1455.0/1465.0/1475.0/1485.0/1495.0/1505.0 and 1515.0 under AFTRCC ICN 1521-26/APP-2026-1719 (Broad Com STA/US Open Tennis-Flushing, NY) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broad Comm Inc operations.
- 2) Unprotected NIB operations are under an MO station class.
- 3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Broad Comm Inc Systems emissions if EMI is detected.
