- (5) Power will not exceed RF output as specified in Rules Parts 21, 74, 78, 90 and 101.
- (6) Operation is subject to prior coordination with Fixed Microwaves and Auxiliary Broadcasting licensees.
- (7) The designated point-of-contact to terminate transmission if interference occurs is Mr. Tom Smith, telephone (858) 391-3050 and Mr. David Van Loucks, telephone (800) 669-9667.
- (8) Upon notification from the FCC, operation on this assignment is subject to immediate cessation if it causes harmful interference to 50 km of Navy assignments.
- (9) Prior to activation, the applicant must coordinate with Air Force and Army within 50 km of the proposed area.
- (10) Operation is subject to coordination with the area frequency coordinator located at White Sands Missile Range, New Mexico, prior to use in the State of New Mexico or other US territory within a 240-km radius of WSMR plus the area of Utah and Colorado that lies South of 41 North and between 108 and 111 West.
