NAME Broadcast Sports International LLC

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Broadcast Sports International be aware of federal ITU registration in the 7259.915-7260.085 MHz band.
- (4) This authorization SUPERSEDES the previously issued authorization with the same call sign and file number: amended conditions.

Special Conditions:

- (5) The applicant must coordinate with the Fixed Microwave Service licensees in each and every proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to operation in 5925-6425 MHz and 6525-6875 MHz bands.
- (6) For operation in the 5.650-5.725 GHz band, the maximum output power from the outdoor access points must not exceed 200mW (23dBm) or 11 dBm + 10 log B, where B is the 26 dB emission bandwidth in megahertz. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1-megahertz band. The maximum antenna directional gain must not exceed 6 dBi.
- (7) For operation in the 5.725-5.850 GHz band, the maximum output power from the outdoor access points must not exceed 1 watt (30 dBm) into a 6 dBi antenna for a total of 36 dBm EIRP. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. The maximum antenna directional gain must not exceed 6 dBi.
- (8) For operation in the 5.925-6.425 GHz and 6525-6875 MHz bands, the maximum output power from the outdoor access points must not exceed 1 watt (30 dBm) into a 6 dBi antenna for a total of 36 dBm EIRP. In addition, the maximum power spectral density shall not exceed 23 dBm in any 1-megahertz band. The maximum antenna directional gain must not exceed 6 dBi.
- (9) The radiated power from outdoor access points must not exceed 21 dBm EIRP at angles of more than 30 degrees above the horizon to protect satellite receivers.
- (10) Prior to commencing any operations in the 5925-6425 MHz frequency band, experimental licensee must notify licensee of Intelsat License LLC (Ms. Susan H Crandall, Phone Number: 703-559-7848, E-Mail: susan.crandall@intelsat.com) and SES Americom, Inc. (Ms. Petra A Vorwig, Phone Number: 202-478-7143, E-Mail:petra.vorwig@ses.com). The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should include the testing parameters (specific location(s), antenna gain(s), antenna height(s), antenna orientation, EIRP, EIRP density) and day and times of each test.
- (11) For the Phoenix/Glendale area: Notch out 7125 - 7145 MHz; 7175 - 7195 MHz; 7220 - 7240 MHz; 7300 - 7320 MHz; 7400 - 7420 MHz; 7485 - 7500 MHz.
- (12) For the Sonoma area: Notch out 7125 - 7135 MHz.
- (13) For the Justin/Dallas area: Notch out 7125 - 7145 MHz; 7165 - 7175 MHz; 7190 - 7205 MHz; 7295 - 7305 MHz; 7445 - 7450 MHz.
- (14) Operations in the 7125-7500 MHz band are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating stations. Broadcast Sports International should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee will be subject to immediate shut down.
- (15) Broadcast Sports International is cautioned that operational use of this system in the 7125-7500 MHz frequency band may not be possible, and Broadcast Sports International shall have no expectations that future requests for operation in this frequency band will be approved.
