MIDLANTAFC does not object to the lower L band and upper S-band usage (Frequency: (MHz) 1435 - 1525 and 2360.0 – 2390.0 under AFTRCC ICN 1573-26/APP-2026-1838 (BSI STA/IMSA Auto Racing-Alton, VA) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports, Intl operations.
- 2) Unprotected NIB operations are under an MO station class.

3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Broadcast Sports, Intl emissions if EMI is detected.
