This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

The purpose of this STA operation is to coordinate wireless audio and video transmission for televised sporting events, and other events, at various venues throughout the US.

- (3) Operations are non-interference basis to Flight Test telemetry and Air Force Spectrum Dependent System.
- (4) Frequency assignment(s) in the bands of 1435-1525 MHz must be coordinated prior to authorization with the DoD Arizona Area Frequency Coordinator (AFC), who also coordinates, as appropriate, with Aerospace and Flight Test Radio Coordinating Council. Use of these frequencies under the authority is subject to such further coordination with the AFC to ensure compatibility with existing users.
- (5) The frequency band 2360-2390 MHz is not included in the AFTRCC coordination: ICN 1563-20/xxxx
