MIDLANTAFC does not object to the lower L band usage (Frequency: (MHz) 1435 - 1525 under AFTRCC ICN 1599-26/APP-2026-1917 (BSI STA/College FB-Atlanta, GA) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports, Intl operations.
- 2) Unprotected NIB operations are under an MO station class.
- 3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Broadcast Sports, Intl emissions if EMI is detected.
