This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Operations are a strict non-interference basis to Flight Test telemetry and Air Force Spectrum Dependent System.
- (4) Frequency assignment(s) in the bands of 1435-1525 MHz and 2360-2395 MHz must be coordinated prior to authorization with the DoD AFMO-US&P and DoD Eastern Area Frequency Coordinator (AFC), who also coordinate, as appropriate, with Aerospace and Flight Test Radio Coordinating Council. Use of these frequencies under the authority is subject to such further coordination with the AFC(s) to ensure compatibility with existing users.
