- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number W911NF-16-C-0086. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Maintain operation separation from the grandfathered earth stations as defined in Part 90, subpart Z, or coordinate an agreement with the grandfathered earth station licensees.
- (6) Experimental licensee must notch the following frequency band:
 - a. 3550-3650 MHz
