- (2) Licensee shall coordinate with the local SBE frequency coordinator and the Fixed Microwave Service licensees prior to operation in 925-960 MHz and 2400-2500 MHz bands
- (3) Licensee shall obtain consents from the EBS and BRS licensees prior to accessing to 2496-2690 MHz and 2570-2620 MHz bands.
- (4) Licensee shall secure consents from the AWS licensees prior to accessing to 1880-1920 MHz band.
