Special Conditions:

- (1) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (2) Operation on Commercial Mobile Radio Services (CMRS) frequencies requires consent of CMRS licensees to avoid interference.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) Operation in the 704-787 MHz band requires consent of all 700 MHz Lower and Upper Blocks A, B and C licensees in the immediate area of testing.
