In response to your May 19, 2017 inquiry in connection with the transfer of control application bearing File No. 0017-EX-TU-2017 ("Application"), the applicants provide the following information.

The Application is one of a series of FCC filings necessary to complete the transaction described in Exhibit 1, Section II to the Application, which includes the indirect transfer of control of CellBlox Acquisitions, LLC ("CellBlox").

1. The following transfer of control applications also have been filed:

With the International Bureau (IB) – International 214 Transfer Applications: Joint Applications, filed May 11, 2017, of Securus Investment Holdings, LLC (Transferor), Securus Technologies, Inc. (Licensee), T-NETIX, Inc. (Licensee) and SCRS Acquisition Corporation (Transferee) for approval to transfer indirect ownership and control of the Licensees to Transferee. See IB File Nos. ITC-T/C-20170511-00094 and ITC-T/C-2017-0511-00095.

With the Wireline Competition Bureau (WCB) – Domestic 214 Transfer Application: Joint Application, filed May 11, 2017, of Transferor, Securus Technologies, Inc. (Licensee), T-NETIX, Inc.
