This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (3) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas.
- (4) Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (5) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
