- (1) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.

Special Conditions:

- (2) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) Licensee must successfully coordinate with the Fixed Microwave Service licensees in each proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to operation in 3.7-3.8 GHz band.
- (8) With respect to operations in 3700-3800 MHz band, the licensee must avoid causing interference to existing Fixed Service operators and FSS earth stations in the band. For licensee's reference, a list of registered incumbent FSS earth stations in the band can be found at the following link:
