Special Conditions:

- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) All of the experimental devices will be under the control of Cellco Partnership and they will be retrieved by Cellco Partnership upon completion of the operation.
- (5) Cellco Partnership is reminded that grant fathered earth stations are protected in within a separation distance of 150 km. The coordinates of these stations are available at: <http://www.fcc.gov/ib/sd/3650/grandftr.pdf>
- (6) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz.
- (7) Ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas.
