Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The applicant shall coordinate with the Fixed Microwave Service licensees in each the proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to operation in the proposed bands.
- (4) With respect to operations in 3700-3800 MHz band, the applicant should be made aware that they must avoid causing interference to existing Fixed Service operators and FSS earth stations in the band. - (5) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (6) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
