The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Operations under the authority of this assignment are subject to immediate adjustment, including cessation, if they result in harmful interference to airborne weather radars.
