Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by National Science Foundation contract numbers NSF-ATM-0724381 and other scientific activities. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (4) Licensee is to be careful to use only those frequencies set forth above that are the best suitable in each given area.

Special Conditions:

- (5) Operation on 163.1 MHz within 15 miles of Houston, TX must be coordinated with Ms. Cathy Sham at 281-483-0124.
- (6) No operation is allowed for using the frequency band 163.7125 MHz.
- (7) Operation in the bands 163.1 MHz is subject to prior coordination with the Society of Broadcast Engineers, Inc. (SBE); ATTN: Executive Director; 9247 North Meridian Street, Suite 305; Indianapolis, IN 46260; telephone, (866) 632-4222; FAX, (317) 846-9120; e-mail, executivedir@sbe.org; information, www.sbe.org
- (8) Operation is used for weather experiment only.
- (9) Licensee shall select operating frequencies in the bands 157.45-161.575 MHz and 173.2-173.4 MHz to avoid interfering with existing users.
