Special Conditions:

- (1) Applicant project limited to proof of concept demonstrations and testing and will not involve live-duty operations to protect life, property, or safety
- (2) Applicant must accept interference from any other user of Band 14 and all operations by Applicant will be on a secondary basis.
- (3) Applicant must verify that there is no current potential for interference with FirstNet operations or those approved to operate in Band 14 per license (i.e., any Band 14 incumbents).
- (4) POC is established and sent to FirstNet upon STA approval with "kill switch" authority; Applicant agrees to cease operations at request of FirstNet immediately upon receipt of request to kill switch POC until such time, as determined by FirstNet, that interference issues are no longer at issue.
- (5) Applicant agrees that First Net has the right to monitor its operations.
